Privacy Policy

What data do we collect?

Our Company collects the following data:

- Personal identification information (name, email address, etc.)
- Prior employment information
- Work eligibility information
- Education information
- Interests and skill information

How do we collect your data?

You directly provide Our Company with most of the data we collect. We collect data and process data when you:

- Apply for employment through the workarctic.com, northernalaskajobs.com, or other Company employment-application websites.
- Use or view our websites via your browser's cookies.

How will we use your data?

Our Company collects your data so that we can:

- Evaluate your application for employment

If you agree, Our Company will share your data with our partner companies so that we can complete the processing of your application. This includes for the purpose of:

- Perform any required drug testing, or

- Receiving your driver record from any applicable Departments of Motor Vehicles.

How do we store your data?

Our Company securely stores your data within our private Staffing Center web-based platform that is maintained by Coolworks.com.

Our Company will keep your information indefinitely, in case you ever re-apply or apply for a different position.

Marketing

Our Company will never use your information for marketing.

What are your data protection rights?

Our Company would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request Our Company for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that Our Company correct any information you believe is inaccurate. You also have the right to request Our Company to complete the information you believe is incomplete.

The right to erasure – You have the right to request that Our Company erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that Our Company restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Our Company's processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that Our Company transfer the data that we have collected to another organization, or directly to you, under certain conditions.
